- The EDC would also recommend that we allow for credentialing within degree programs to better exemplify workforce readiness.
- Finally, the EDC would ask for more discretion at the institution level in the application of Oklahoma's Promise to serve as a stop-gap for those students who would otherwise be lost to financial difficulty after enrollment.
